PRESIDENT'S COLUMN

Greetings Chapter members, the fourth quarter is now upon us and I hope it finds you well. It has been an eventful year, which will provide future challenges and opportunities to the incoming leadership and members.

The past year has seen highs and lows. The beginning of the year saw the death of a state mandated licensing bill, which with any luck will be a mute point when the federal financial reforms are implemented. Mid-year brought a dispute between AI and the Appraisal Foundation, with the AF intending to impose sanctions on AI. As a result our leadership concluded it was in the best interest of the organization and its members to withdraw its sponsorship of the Foundation.

In the short term, this action will result in some increased costs to members with regards to obtaining USPAP in particular. In the long term, this action emphasizes and makes known the importance, ability and necessity of AI to promote the interests of its members without the influence, direction or approval of outside parties, which may be contrary to the mission of AI. I believe our leadership took the proper action to maintain the independence of the organization.

In the final quarter of the year, I highly recommend that you review the core competency model which is in 45-day notice and available on the website. It is a model utilized by other professional organizations, and it provides the AI with the ability to attract additional non-traditional members and professionals, who may not be directly involved in real property. This action also appears to represent a long term benefit to the AI.

Mark your calendars for November 11, 2010! We will be presenting our Year-in-Review Symposium. Invite your co-workers, colleagues, clients, lenders, other members and nonmembers. It is a highly informative presentation by appraisers and market participants as to the state of various segments of the industry. We were fortunate to retain Joe Magdziarz (Mags) as our keynote speaker. Joe is the incoming president of the Institute, and if you've ever had him as an instructor or heard him speak, you know of his intelligence and expertise, on top of the fact that he tells a great story.

As this is my final column, I wish to thank everyone who assisted me over the course of the year, you are too numerous to mention individually, and have my sincere thanks. Thankyou to Chris and Doug, (Heather-for your patience) at WAM for your attention to detail. I want to thank my fellow officers, directors and committee heads of the Wisconsin Chapter.
