Appraising Condos, Co-ops, and PUDs

WCAI Office

Single-family attached homes like condominiums, cooperatives, and townhouses are the primary housing option in many urban markets. New construction detached houses are typically in subdivisions and master plan communities. Age-restricted communities are popular with retirees. Most of these developments have one thing in common: they all have associations which are governed by condominium declarations, bylaws, and/ or covenants, conditions, and restrictions which affect the bundle of rights. The first part of this seminar builds the foundation for the discussion on appraising residential properties in community associations. You'll learn why it is necessary to know how to identify the property type, why it is important to have a full understanding of the governing documents, why you need to understand where it is located, and why it's critical to analyze the market. UPDATE FROM REGION 3 – WI CHAPTER

Region 3 comprises the WI, Chicago, North Star, and Great Lakes Chapters of the Appraisal Institute. The Region serves as a conduit between concerns at the Chapter level and provides that feedback to the National Board. Region 3 held its first virtual Region Meeting for 2024 on January 30, 2024. Regions through the US will hold a virtual Joint Regional Meeting on February 20th, where AI President Adomatis will be asking for each Region to provide a summary of success stories from their Chapters. The 2 items that the WI Chapter will be sharing from Region 3 are:

1st Annual Lobby Day planned for Tuesday March 12th. Lobby day will focus on upcoming discussions about PAREA and include a visit with AI's Scott DiBiasio, Manger of State and Industry Affairs; meetings with legislators; and a tour of the Capitol.

19th Annual Condemnation Symposium to be held Thursday May 23rd. This Chapter Developed course held at the Marquette Law School included 79 in-person registrants and 34 on-line registrants in 2023. This cross discipline symposium is one of the reasons why 70% of the WI Chapter's education registrations in 2023 were from non-members of the AI Chapter.
